Selection Criteria

To discriminate and measure the performance of National Entrepreneurs' Day Award Aspirants, the Award Selection Committee of National Foundation for Entrepreneurship Development (NFED) has devised the selection criteria and star status. The national award selection process includes scrutinizing of nomination form along with the required supportive documents in accordance with fulfilling the mandatory requirements. This followed by recommendations of award juries to the selection committee in adherence to stratification with regard to award categories and finally assigning the star status. There will be a sentence describing the Award Status of all the Awardees in lieu of their selection to NFED's 10th National Entrepreneurs' Day Awards 2023.
