- ❖ Individuals interested in participation only for the [Global Conclave](#) can register via [Online Registration Link](#) directly by filling the required details. Award felicitations are **Not Applicable** for this category. No requirement to submit any documents. *[Participation Charges](#) has to be paid only after receiving the payment link, which will be emailed upon receiving the registration details. Ceremony Invitation will be sent only for the Paid and Registered Participants.

2. Every nomination will be subjected to a thorough scrutiny on all the information provided by the award aspirant and subsequent recommendations by the Award Juries and / or Award Chair / Chairman of Selection Committee, wherein his / her decision on award endorsement stands final.
3. Candidates providing falsified / erroneous information or into any malpractices or engaging in canvassing for their award to the Award Chair / Chairman and / or Selection Committee Members / Award Jury / Presidium Members directly or indirectly will be rejected.
4. Confirmation of Award Selection will be intimated via Pre-Endorsement Email along with Awardee Declaration Form. The Award Processing Charges shall be paid thereafter.
5. The Award Endorsement Letter will be emailed only upon receiving the Signed Declaration Form and Award Processing Charges from the selected awardee.
6. The selected national awardees will be officially listed in the NFED Awards Website post-award ceremony.
7. The award processing charges do NOT include any cash prizes, travel or accommodation expenses for the Awardee/Guest(s).
